The Indian Institute of Science Education and Research Thiruvananthapuram (IISER-TVM) invites applications for the post of "Project Engineer cum Estate Officer" on direct/deputation basis.

Pay: PB-3 15600-39100 with Grade pay 6600/-

Age:

- i) Not exceeding 50 Years for direct recruitment
- ii) Preferably below 55 years for deputation

Essential Qualification (For Direct recruitment): First class Bachelor's Degree or equivalent grade in Civil Engineering from a recognized University/Institute

AND

Minimum 5 years' in relevant field as Engineer / Asst. Executive Engineer (in PB3 with Grade pay Rs.5400) from CPWD/ State PWD or similar organized services/ Semi-Govt./ PSU/ Statutory or Autonomous organization / Universities / reputed institute or organizations under Central / State Govt.

Desirable Qualification:

- i) Working Knowledge of Computer Aided Design (CAD) and other relevant software applications and latest management technology.
- ii) Proven track record of handling projects / works in reputed organization or relevant magnitude and qualities.
- iii) Experience of working with high tension lines, electrical maintenance planning and execution of electrical works or civil engineering, designing and estimation, construction management etc.. as relevant to the profession.

Essential Qualification (For deputation): Officers of the CPWD/State PWD or similar organized services/ Semi-Govt./ PSC/ Statutory or Autonomous organization, University, Institute of National Importance etc..

- i) Holding analogous posts or
- ii) With at least 5 years regular service in posts in the PB3 with Grade pay of Rs.5400/- as Assistant Executive Engineer / Assistant Engineer as per 6th Central Pay commission or equivalent and
- iii) Possessing educational qualification and experience as mentioned above.

General Conditions & Instructions:

- 1) This post is as per the Central Government pay scales and carries allowances like Dearness Allowance, House Rent, Transport etc. and eligible to have other benefits like Medical Reimbursements, LTC, etc. as per the Government/Institute norms as admissible to Central Government employees. This post will be covered by the New Defined Contributory Pension Scheme as per the Govt. of India, Ministry of Finance Notification No.5/7/2003-ECB&PR dated 22nd December, 2003 (not applicable in case of deputation).
- 2) Age limit and qualification will be reckoned as on the last date of receipt of application.
- 3) Candidates working in Govt. organization/Public sector undertaking/Govt. funded research agencies should submit their application through proper channel. However, an advance copy of the application together with application fee may be sent directly.
- 4) If the application is not sent through proper channel "No Objection Certificate" from the parent organization has to be submitted at the time of interview.
- 5) The prescribed Qualifications /Experience indicated are the minimum and mere possession of the same will not entitle the candidates to be called for interview. Where number of applications received in response to the advertisement is large, the Institute may restrict the number of candidates to be called for interview to a reasonable limit on the basis of qualifications and experience higher than the minimum prescribed in the advertisement. The applicants should, therefore, furnish details of all qualifications and experience, with copies of certificates.
- 6) Certificate in support of experience should be on the organization's letter head with date of issue, details of post held and period of work. The certificate should bear the name, designation and contact details of the issuing authority.
- 7) Outstation candidates called for interview will be paid to and fro AC II rail fare from the place of residence or from the actual place of commencement of the journey, whichever is nearer to the place of the interview.
- 8) The institute reserves the right not to fill up the vacancy advertised without assigning reasons thereof.
- 9) Canvassing in any form and/or bringing any influence will be treated as a disqualification.
- 10) Applications should be accompanied with a demand draft for Rs 200/- drawn in favour of IISER-TVM and payable at Thiruvananthapuram. No other mode of payment will be accepted. Candidates belonging to SC/ST category is exempted from paying application fees. Application fee will not be refunded or readjusted under any circumstances.
- 11) Applications incomplete in any respects and/or not accompanied by relevant certificates / documents / photograph/application fee are liable to be rejected.
