- All the bidders will have to submit earnest money deposit (EMD) of Rs. 1,71,740/- in the form of Demand Draft/Bank Guarantee/ Term deposit only from a scheduled Bank in favour of Indian Institute of Science Education and Research, payable at Thiruvananthapuram in the sealed cover along with their highest offer. Offers without EMD shall be summarily rejected.
- The bidder should satisfy himself about the material before taking part in the auctions.
- Quotations in sealed cover along with EMD address to the Project Engineer cum Estate Officer, IISER-TVM should reach his office on or before 14:30 hrs on 11/08/2015 and will be opened at 15:00 hrs on the same day.
- Immediately after opening the quotation and intimating the offer or the acceptance of the offer made by him, bidder should remit the entire amount to the IISER-TVM within 7 days (seven days) from the date of intimation. In case the successful bidder fails to deposit the full bid amount within stipulated time period, the EMD submitted

- by the bidder shall be forfeited and the Sale stand cancelled. Also the defaulter bidder has to be debarred from the bidding in future.
- The earnest money of unsuccessful bidder will be returned to them on confirming the sale and that of successful bidder will be retained till the collection of the items are completed.
- 8. The material will have to be collected by successful bidder on the basis of "ON AS IS WHERE IS". And the department will not be responsible for giving the material by measurement etc. no claim whatsoever regarding quality, quantity, measurement shall be entertained.
- The successful bidder should quote the amount bearing in mind the upset value given in brackets and offers will be considered only based on the reasonableness of each offers.
- 10. The sale will be normally confirmed on the highest offer. The Project Engineer cum Estate Officer, reserves the right to reject any offer or to cancel the auction without assigning any reason.
- 11. The successful bidder will be permitted to collect the items from IISER-TVM for a period decided by the Project Engineer-cum-Estate Officer, after which he shall have no claim over the sold items. However, the materials will be allowed to be removed only after payment of offer money.
- 12. The successful bidder shall be responsible for any kind of loss to the Govt. property by him during the removal of the auctioned articles from the site and recovery of the same will be made from him.
- 13. The required T&P and the ways & means of taking out/ dismantling of the auctioned material and their final removal from the site shall be responsibility of the successful bidder. No request for extra cost and/or T&P shall be entertained by the department.

- 17. If the bidder does not vacate the site within period allowed, the Project Engineer-cum-Estate Officer may confiscate the balance material lying at the site.
