Sub:- Notice Inviting Offers for Hiring of flats/villas/buildings for Guest House / <u>Transit Accommodation and Office Space – 2019</u>

The institute requires buildings on rent for the following purposes: -

Guest House/Transit Accommodation (with 6-10 rooms) and office space:-

Fully furnished Flats/Villas/Buildings will be considered depending upon their features, location, furnishings (including furniture) etc. Necessary alteration / addition etc. for meeting the user requirements of the institute need to be done by the owner.

- 2. Preferred Locations: Chakai, Kowdiar, Peroorkada, Sreekaryam, Kulathoor, West Fort / Prime areas in Thiruvananthapuram
- 3. **Period**: Initially for 2 (two) years (may be extended further based on the requirements) the buildings are required for immediate occupation or by July / Aug 2019.
- 4. Persons having Flats/Villas/Buildings buildings, meeting the above requirements may make their offers. The offers should consists of following details with the documentary proof: -
- (i) Location details with sketch
- (ii) Ownership and registration under municipal authority
- (iii) Space (plinth area and carpet / floor area) and building plan with approach and access
- (iv) Electric Power supply specifications with load ratting and tariff details
- (v) Water Supply and Storage Facilities (should have standby facilities in case of breakdown from outside sources).
- (vi) Fixtures & Furnishings
- (vii) Compound area with vehicle parking space
- (viii) Building Maintenance / Care-taker arrangements
- (ix) Provisions for waste disposal
- (x) Expected monthly rent
- (xi) Any other particulars

- 5. The charges for electricity power consumption and water charges will be paid by the institute on production of bill / receipt from KSEB / Water authority. The dues if any, till date of occupation are to be cleared by the owner.
- 6. All municipal and other statutory taxes liabilities are to be borne by the building owner. Cleaning of sewages, soak pits, septic tanks etc is to be done by the owner at his expenses and arrangement on as and when required basis.
- 7. The compound should have necessary arrangements for waste disposal. In the absence of same, the provision for waste disposal has to be made available at owners risk / expense on day to day basis.
- 8. The premises on offer will be considered on the basis of institute's requirements and preferences and such parties will be invited for further discussions. The institute reserves the right to not to consider any one or all the offers without giving any reasons.
