Research experience <u>should be supported</u> by a certificate from the previous employer/s. Candidates should bring originals of all applicable certificates (qualifying degrees, national examinations, category certificate, etc) during the interview. No TA/DA will be paid for appearing for the interview. Applications failing to the meet minimum criteria will not be considered. Interviews may be conducted over skype videoconferencing only in exceptional cases if the applicant indicates this beforehand.</p>

Where number of applications received in response to this advertisement is large, it will not be convenient or possible to interview all the candidates. Based on the recommendations of the Screening Committee, the Project Leader/ Principal Investigator may restrict the number of candidates to be called for the interview to a reasonable limit after taking into consideration qualifications and experience over and above the minimum prescribed in the advertisement.
