Research experience <u>should be supported</u> by a certificate from the employer(s). Candidates

	should bring originals of all applicable certificates (qualifying degrees, national examinations, category certificate, etc) during the interview. No TA/DA will be paid for appearing for the interview. Applications failing to the meet minimum criteria will not be considered.

Applicants must bring all certificates (original + one copy) at the time of interview for the purpose of verification.

General Information

3. Appointment of the applicant will be governed by the terms and conditions of the funding agency particularly applicable to the said project
