Subject: Amendment in the First Statutes of Indian Institute of Science Education & Research Thiruvananthapuram (IISER TVM) regarding temporary arrangement in the event of vacancy arising in the post of Chairperson.

The undersigned is to convey the approval of the BoG to the amendment of Statutes as follows:

All the regular appointments for the positions classified as group 'A' (Pay Band III and above) or equivalent positions shall be approved by the Chairperson, Board of Governors on the recommendations of the selection committees constituted for this purpose as per the provisions of the Act and Statutes of the Institute. The same shall be reported to the Board of Governors at its subsequent meeting(s).	by reason of expiry of his or her tenure, death, resignation or otherwise or in the event of the Chairperson being unable to discharge his or her functions owing to absence, illness or any other cause, the Chairperson of an Institute of National Importance, may discharge the functions assigned to the Chairperson, for a period of six months or till the nomination of a regular Chairperson, whichever is earlier, with the approval of the Visitor and in case of expiry of tenure, the Visitor may extend the term of the incumbent Chairperson for a period of six months or till the nomination of a regular Chairperson, whichever is earlier.
