

KIND ATTENTION TO THE CANDIDATES OFFERED FOR PHD ADMISSIONS 2019

Candidates those who have been offered for PhD admission are required to note down following points to join IISER-TVM:

- 1) **Date of registration and commencement of programme:** You are required to report for registration for the Integrated Ph.D. programme on **25th July, 2019 (Reporting Time: 9 AM)** at the Institute's permanent campus located at Maruthamala, Vithura, Thiruvananthapuram - 695 551. - 2) All the selected candidates are to be prepared themselves in staying the campus from the date of registration (i.e 25.7.2019 onwards).
- 3) **Payment of fees & mode of fee payment:**

i) Fee: Applicable fee for Varsha 2019 (New) is as given below:

ii) Mode of payment: Through [SBI Fee collect](http://www.iisertvm.ac.in/files/read/sbi_collect_instrcutions) (steps given in the link: http://www.iisertvm.ac.in/files/read/sbi_collect_instrcutions). Payment of fees for the semester as aforesaid and for the mess to be made separately and printout of the transaction to be submitted at the time of registration along with other required documents as listed in (f).

iii) Receipt of successful transaction of above payments to be brought as a documentary proof.

- 4) **Requirement of documents at the time of Registration:** Following documents are required to be produced at the time of registration, without which the registration will not be facilitated:

- i) Proof of Identity and/or Proof of Date of Birth
- ii) 10th & 12th Standard Certificate (10th std. certificate may be used for (i) above)
- iii) Degree certificate & consolidated marks statement of Under Graduate
- iv) Degree certificate & consolidated marks statement of Post Graduate
- v) Sanction Order/Award letter issued by the funding agency confirming the selection of candidature as Junior Research Fellow (JRF) (applicable to the candidates of external funding agencies)
- vi) Documentary Proof of qualification in one of the National Level Eligibility Tests (applicable to the candidates qualified for GATE/JEST/JEEBILLS etc..)
- vii) AADHAR enrolment/id (required in case of Direct Benefit Transfer (DBT); to be linked with bank account)
- viii) Valid OBC-NCL Certificate in prescribed format issued on or after 1.4.2019 by the competent authority (applicable to the candidates of OBC-NCL)
- ix) Caste certificate in prescribed format issued by the competent authority (applicable to the candidates from reserved categories)
- x) Hardcopy of transaction of payment of fees & mess charges through SBI Fee Collect
- xi) Other details: Present/Communication Address and Permanent address, Email id, Mobile No. and five copies of your recent passport size photograph etc..

Please note that the documents mentioned in i) to iv) & ix) are to be brought in original for verification and return purposes. And self-attested copies of documents listed in i) to iv) & ix) to also be brought for records purposes. Originals of remaining documents will be kept in the office records for further process.
