Candidate should also attach a detailed resume with contact details (phone number, email and postal address), educational and essential qualifications, and sufficient information on past research experiences and reprints of papers. Applications failing to the meet minimum criteria will not be considered. Incomplete applications will be disqualified. (a passport-size photo to be attached in the application form)

The shortlisted candidates will be informed about the interview date and time by email.

Applicants must bring all the certificates of age, educational and essential qualifications (original + one photocopy), passport size photograph and the original certificate of experience as JRF at the time of joining for the purpose of verification.

General Information

1. Appointment is purely temporary and will terminate automatically without any notice or compensation on termination of the research project.
2. The appointed person shall have no claim of appointment / absorption in Funding Agency or in IISER Thiruvananthapuram.
3. Appointment of the applicant will be governed by the terms and conditions of the funding agency particularly applicable to the said project
4. The qualification prescribed should have been obtained from recognized Universities / Institutions.
5. The prescribed educational qualifications are the bare minimum and mere possession of same does not entitle candidates to be called for interview. Where number of applications received in response to this advertisement is large, it will not be convenient or possible to interview all the candidates. Based on the recommendations of the Screening Committee, the Project Leader/ Principal Investigator may restrict the number of candidates to be called for the interview to a reasonable limit after taking into consideration qualifications and experience over and above the minimum prescribed in the advertisement. Therefore, it will be in the interest of the candidates, to mention all the qualifications and experience in the relevant field at the time of applying.
