## ANNEXUE: 1 Instructions for Online Bid Submission

- 1) The bidders are required to submit soft copies of their bids electronically on the CPP Portal, using valid Digital Signature Certificates. The instructions given below are meant to assist the bidders in registering on the CPP Portal, prepare their bids in accordance with the requirements and submitting their bids online on the CPP Portal.
- 2) More information useful for submitting online bids on the CPP Portal may be obtained at: https://eprocure.gov.in/eprocure/app.

### 4) REGISTRATION

- 5) Bidders are required to enroll on the e-Procurement module of the Central Public Procurement Portal (URL: https://eprocure.gov.in/eprocure/app) by clicking on the link "Online bidder Enrollment" on the CPP Portal which is free of charge.
- 6) As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.
- 7) Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the CPP Portal.
- 8) Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (Class III Certificates with signing key usage) issued by any Certifying Authority recognized by CCA India (e.g. Sify / nCode / eMudhra etc.), with their profile.
- 9) Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSC's to others which may lead to misuse.
- 10) Bidder then logs in to the site through the secured log-in by entering their user ID / password and the password of the DSC / e-Token.

## SEARCHING FOR TENDER DOCUMENTS

- 1) There are various search options built in the CPP Portal, to facilitate bidders to search active tenders by several parameters. These parameters could include Tender ID, Organization Name, Location, Date, Value, etc. There is also an option of advanced search for tenders, wherein the bidders may combine a number of search parameters such as Organization Name, Form of Contract, Location, Date, Other keywords etc. to search for a tender published on the CPP Portal.
- 2) Once the bidders have selected the tenders they are interested in, they may download the required documents / tender schedules. These tenders can be moved to the respective 'My Tenders' folder. This would enable the CPP Portal to intimate the bidders through SMS / email in case there is any corrigendum issued to the tender document.
- 3) The bidder should make a note of the unique Tender ID assigned to each tender, in case they want to obtain any clarification / help from the Helpdesk.

## PREPARATION OF BIDS

- 1) Bidder should take into account any corrigendum published on the tender document before submitting their bids.
- 2) Please go through the tender advertisement and the tender document carefully to understand the documents required to be submitted as part of the bid. Please note the number of covers in which the bid documents have to be submitted, the number of documents - including the names and content of each of the document that need to be submitted. Any deviations from these may lead to rejection of the bid.
- 3) Bidder, in advance, should get ready the bid documents to be submitted as indicated in the tender document / schedule and generally, they can be in PDF / XLS / RAR / DWF/JPG formats. Bid documents may be scanned with 100 dpi with black and white option which helps in reducing size of the scanned document.
- 4) To avoid the time and effort required in uploading the same set of standard documents which are required to be submitted as a part of every bid, a provision of uploading such standard documents (e.g. PAN card copy, annual reports, auditor certificates etc.) has been provided to the bidders. Bidders can use "My Space" or "Other Important Documents" area available to them to upload such documents. These documents may be directly submitted from the "My Space" area while submitting a bid, and need not be uploaded again and again. This will lead to a reduction in the time required for bid submission process.

Note: My Documents space is only a repository given to the Bidders to ease the uploading process. If Bidder has uploaded his Documents in My Documents space, this does not automatically ensure these Documents being part of Technical Bid.



#### SUBMISSION OF BIDS

- Bidder should log into the site well in advance for bid submission so that they can upload the bid in time i.e. on or before the bid submission time. Bidder will be responsible for any delay due to other issues.
- The bidder has to digitally sign and upload the required bid documents one by one as indicated in the tender document.
- 3) Bidder has to select the payment option as "offline" to pay the tender fee / EMD as applicable and enter details of the instrument.
- 4) Bidder should prepare the EMD as per the instructions specified in the tender document. The original should be posted/couriered/given in person to the concerned official, latest by the last date of bid submission or as specified in the tender documents. The details of the DD/any other accepted instrument, physically sent, should tally with the details available in the scanned copy and the data entered during bid submission time. Otherwise the uploaded bid will be rejected.
- 5) Bidders are requested to note that they should necessarily submit their financial bids in the format provided and no other format is acceptable. If the price bid has been given as a standard BoQ format with the tender document, then the same is to be downloaded and to be filled by all the bidders. Bidders are required to download the BoQ file, open it and complete the white coloured (unprotected) cells with their respective financial quotes and other details (such as name of the bidder). No other cells should be changed. Once the details have been completed, the bidder should save it and submit it online, without changing the filename. If the BoQ file is found to be modified by the bidder, the bid will be rejected.
- 6) The server time (which is displayed on the bidders' dashboard) will be considered as the standard time for referencing the deadlines for submission of the bids by the bidders, opening of bids etc. The bidders should follow this time during bid submission.
- 7) All the documents being submitted by the bidders would be encrypted using PKI encryption techniques to ensure the secrecy of the data. The data entered cannot be viewed by unauthorized persons until the time of bid opening. The confidentiality of the bids is maintained using the secured Socket Layer 128 bit encryption technology. Data storage encryption of sensitive fields is done. Any bid document that is uploaded to the server is subjected to symmetric encryption using a system generated symmetric key. Further this key is subjected to asymmetric encryption using buyers/bid opener's public keys. Overall, the uploaded tender documents become readable only after the tender opening by the authorized bid openers.
- 8) The uploaded tender documents become readable only after the tender opening by the authorized bid openers.
- 9) Upon the successful and timely submission of bids (i.e. after Clicking "Freeze Bid Submission" in the portal), the portal will give a successful bid submission message & a bid summary will be displayed with the bid no. and the date & time of submission of the bid with all other relevant details.
- 10) The bid summary has to be printed and kept as an acknowledgement of the submission of the bid. This acknowledgement may be used as an entry pass for any bid opening meetings.

#### ASSISTANCE TO BIDDERS

- 1) Any queries relating to the tender document and the terms and conditions contained therein should be addressed to the Tender Inviting Authority for a tender or the relevant contact person indicated in the tender.

## ANNEXURE- 2 : SPECIAL CONDITIONS OF CONTRACT

- 1.1. ELIGIBLE BIDDERS.
- 1.1.1 This Invitation for Bids is open to all suppliers.
- 1.1.2 Bidders should not be associated, or have been associated in the past, directly or indirectly, with a firm or any of its affiliates which have been engaged by the Purchaser to provide consulting services for the preparation of the design, specifications, and other documents to be used for the procurement of the goods to be purchased under this Invitation of Bids.
- 1.2. Cost of Bidding
- 1.2.1 The Bidder shall bear all costs associated with the preparation and submission of its bid, and "the Purchaser", will in no case be responsible or liable for these costs, regardless of the conduct or outcome of the bidding process.
- 1.3. FRAUD AND CORRUPTION:
- 1.3.1 The purchaser requires that the bidders/suppliers and contractors observe the highest standard of ethics during the procurement and execution of such contracts.
- 1.3.2 The purchaser will reject a proposal for award if it determines that the Bidder recommended for award has, directly or through an agent, engaged in corrupt, fraudulent, collusive or coercive practices in competing for the Contract in question;
- The Bidding Documents

  1.4. Cost of Bidding Documents
- 1.4.1 Interested eligible bidders may download the document from our Website. However the bid document cost to be paid during the submission of the bid.
- 1.5. CONTENT OF BIDDING DOCUMENTS
- 1.5.1 The goods required, bidding procedures and contract terms are prescribed in the bidding documents which should be read in conjunction.
- 1.5.2 The Bidder is expected to examine all instructions, forms, terms, and specifications in the bidding documents. Failure to furnish all information required by the bidding documents or submission of a bid not substantially responsive to the bidding documents in every respect will be at the Bidder's risk and may result in rejection of its bid.
- 1.6. CLARIFICATION OF BIDDING DOCUMENTS
- 1.6.1 A prospective Bidder requiring any clarification of the Bidding Documents shall contact the Purchaser in writing via fax/email. The Purchaser will respond in writing to any request for clarification, provided that such request is received not later than ten (10) days prior to the deadline for submission of bids. The Purchaser shall forward copies of its response to all those who have acquired the Bidding Documents directly from it, including a description of the inquiry but without identifying its source. Should the Purchaser deem it necessary to amend the Bidding Documents as a result of a clarification, it shall do so following the procedure under clause relating to amendment of Bidding documents and Clause relating to Deadline for Submission of Bids. The clarifications and amendments issued would also be hosted on the website of the purchaser for the benefit of the other prospective bidders.
- 1.7. AMENDMENT OF BIDDING DOCUMENTS
- 1.7.1 At any time prior to the deadline for submission of bids, the Purchaser may, for any reason, whether at its own initiative or in response to a clarification requested by a prospective bidder, modify the bidding documents by amendment.
- 1.7.2 All prospective bidders who have received the bidding documents will be notified of the amendment in writing or by e-mail and will be binding on them. The same would also be hosted on the website of the purchaser and all prospective bidders are expected to surf the website before submitting their bids to take cognizance of the amendments.
- 1.7.3 In order to allow prospective bidders reasonable time to take the amendment into account, while in preparing their bids, the Purchaser, at its discretion, may extend the deadline for the submission of bids and host the changes on the website of the purchaser.
- 1.7.4 In case of any amendment to the bid, it will be done at least 7 days before due date and will be published in website. Bidders are required to keep this in view before submission. Normally extension of due date will not be entertained. However in special cases if due date is extended, it will be notified under the same tender notice before 3 days of due date.

### PREPARATION OF BIDS

- 1.8. LANGUAGE OF BID
- 1.8.1 The bid prepared by the Bidder, as well as all correspondence and documents relating to the bid exchanged by the Bidder and the Purchaser, shall be written in English language only especially when the details are technical.
  - However of GOI makes it mandatory under Rajbhasha Abhniyam in that case views of Rajbasha unit of IISER-TVM may be sought.
- 1.8.2 The Supplier shall bear all costs of translation, if any, to the English language and all risks of the accuracy of such translation, for documents provided by the Supplier.
- 1.9. DOCUMENTS COMPRISING THE BID
- 1.9.1 The bid prepared by the Bidder shall include:
  - a) Bidder Information
  - b) Bid security as specified in the Invitation to Bids.
  - c) Service support details



- Deviation Statement if any. d)
- Performance Statement.
- Manufacturer's Authorization. f)
- Documentary evidence establishing that the bidder is eligible to bid and is qualified to perform g) the contract if its bid is accepted.

- Applicable Price Schedule Form. i)
- DGS&D Registration certificate in case the items under procurement falls under the restricted k) category of the current export-import policy of the Govt. of India.

#### BID FORM AND PRICE SCHEDULE 1.10.

The bidder shall complete the Bid with the appropriate price schedule. 1.10.1

#### BID PRICES 1.11.

- The Bidder shall indicate on the appropriate price schedule, the unit prices and total bid prices of the 1.11.1 goods it proposes to supply under the contract.
- Prices indicated on the price-schedule form shall be entered separately in the following manner: 1.11.2

## (A) FOR GOODS MANUFACTURED WITHIN INDIA

- (i) The price of the goods quoted Ex-works including taxes already paid.
- (ii) VAT and other taxes like excise duty etc [shall be shown extra] which will be payable on the goods if the contract is awarded.
- a. The charges for inland transportation, insurance and other local services required for delivering the goods at the desired destination as specified in the price schedule.
- b. The installation, commissioning and training charges including any incidental services, if any.

## (B) FOR GOODS MANUFACTURED ABROAD

Bidders are required to show break-up of Ex-works [which should include packing and handling charges], FOB/FCA and CIF/CIP price in the quotation. IISERTVM has a mechanism for consolidation and customs clearance. The consolidators will be nominated for this purpose at the time of awarding the contract if desires so.

- (i) The price of the goods, quoted on FCA (named place of delivery abroad) or FOB (named port of shipment), as specified in the price schedule.
- (ii) The charges for insurance and transportation of the goods to the port/place of destination.

## (iii) The agency commission charges should be shown, if any.

- (iv) The installation, commissioning and training charges including any incidental services, if any The terms FOB, FCA, CIF, CIP etc shall be governed by the rules prescribed in the current edition 1.11.3
- of the Incoterms published by the International Chambers of Commerce, Paris. Where there is no mention of packing, forwarding, freight, insurance changes, taxes etc. such offer shall
- 1.11.4 be rejected as incomplete.
- The price quoted shall remain fixed during the contract period and shall not vary on any account 1.11.5 All lots and items must be listed and priced separately in the Price Schedules. If a Price Schedule shows 1 11 6 items listed but not priced their prices shall be assumed to be included in the prices of other items. Lots
- or items not listed in the Price Schedule shall be assumed to be not included in the bid. The purchases made by the purchaser for scientific purpose are exempt from Custom Duty under 1.11.7 notification 51/96.

#### BID CURRENCIES 1.12.

- Prices shall be quoted in Indian Rupees for offers received for supply within India and in freely convertible 1.12.1 foreign currency in case of offers received for supply from foreign countries.
- DOCUMENTS ESTABLISHING BIDDER'S ELIGIBILITY AND QUALIFICATIONS 1.13.
- The bidder shall furnish, as part of its bid, documents establishing the bidders' eligibility to bid and its 1.13.1 qualification to perform the contract if its bid is accepted.
- The documentary evidence of the bidders qualification to perform the contract if the bid is accepted shall 1.13.2 establish to the purchasers satisfaction that;
  - (a) The bidder meets the qualification criteria listed in bidding documents, if any.
  - (b) Bidder that doesn't manufacture the goods it offers to supply shall submit to Manufacturers' Authorization Form (MAF) to demonstrate that it has been duly authorized by the manufacturer of the goods to quote and/or supply the goods.
  - (c) In case a bidder not doing business within India, it shall furnish the certificate to the effect that the bidder is or will be represented by an agent in India equipped and able to carry out the supply, maintenance, repair obligations etc. during the warranty and post warranty period or ensure a mechanism at place for carrying out the supply, maintenance, repair obligations etc. during the warranty and post-warranty period.
- 1.13.3 Conditional tenders shall not be accepted

#### DOCUMENTS ESTABLISHING GOODS' ELIGIBILITY AND CONFORMITY TO BIDDING DOCUMENTS 1.14.

- To establish the goods' eligibility, the documentary evidence of the goods and services eligibility shall 1.14.1 consist of a statement on the country of origin of the goods and services offered which shall be confirmed by a certificate of origin at the time of shipment.
- To establish the conformity of the goods and services to the specifications and schedule of requirements 1.14.2 of the bidding document, the documentary evidence of conformity of the goods and services to the bidding documents may be in the form of literature, drawings and data, and shall consist of: (a) A detailed description of the essential technical and performance characteristics of the goods;

(b) A list giving full particulars, including available sources and current prices, of spare parts, special tools, etc., necessary for the proper and continuing functioning of the goods during the warranty period following commencement of the use of the goods by the Purchaser in the Priced bid; and (c) An item-by-item commentary on the Purchaser's Technical Specifications demonstrating substantial responsiveness of the goods and services to those specifications or a statement of deviations and exceptions to the provisions of the Technical Specifications. 1.14.3 For purposes of the commentary to be furnished pursuant to above, the Bidder shall note that standards for workmanship, material and equipment, designated by the Purchaser in its Technical Specifications are intended to be descriptive only and not restrictive. The Bidder may substitute these in its bid, provided that it demonstrates to the Purchaser's satisfaction that the substitutions ensure substantial equivalence to those designated in the Technical Specifications. 1.15. BID SECURITY The Bidder shall furnish, as part of its bid, a bid security (BS) for an amount as specified in the Invitation 1.15.1 for Bids. In the case of foreign bidders, the BS shall be submitted either by the principal or by the Indian agent and in the case of indigenous bidders; the BS shall be submitted by the manufacturer or their specifically authorized dealer/bidder. 1.15.2 The bid security shall be in Indian Rupees for offers received for supply within India and denominated in the currency of the bid or in any freely convertible foreign exchange in the case of offers received for supplies from foreign countries in equivalent Indian Rupees. The bid security shall be in one of the following forms at the bidders' option: (a) A bank guarantee issued by a Nationalized/Scheduled bank/Foreign Bank operating in India in the form provided in the bidding documents and valid for 45 days beyond the validity of the bid. In case a bidder desires to submit a BG issued from a foreign bank, then the same should be confirmed by a Nationalized/Scheduled Indian bank; or (b) Fixed Deposit receipt pledged in favour of the IISER-TVM. (c) A Banker's cheque or demand draft in favour of IISERTVM issued by any Nationalised/Scheduled Indian bank. The bid security shall be payable promptly upon written demand by the purchaser in case the conditions 1.15.3 listed in the ITB clause 15.11 are invoked. The bid security should be submitted in its original form. Copies shall not be accepted. 1.15.4 1.15.5 While Bid security (EMD) is a requirement, the Director IISER-TVM may grant exemption of Bid security to some specific parties having sound credentials and are of national/international repute. The bid security of unsuccessful bidder will be discharged /returned as promptly as possible positively 1.15.6 within a period of 15 days after the expiration of the period of bid validity or placement of order whichever is later, without any interest. The successful Bidder's bid security will be discharged upon the Bidder furnishing the performance 1.15.7 security, without any interest. Alternatively, the BS could also be adjusted against PS, if it is paid through DD/BC. The firms registered with DGS&D, NSIC if any, are exempted from payment of bid security (BS) 1.15.8 provided such registration includes the item they are offering which are manufactured by them and not for selling products manufactured by other companies. 1.15.9 In case a bidder intimates at the time of tender opening in writing that the bid security is kept inside the financial bid, then in such cases, the technical bid of the party would be accepted provisionally till opening of the financial bids with which the party has attached the bid security. 8. Software for operation, image processing, and data analysis:

The AFM system should have separate software for data analysis and data acquisition.

 Able to perform multi-tasking with windows based data acquisition, or equivalent image processing programs at the same time.

 The software must be available free of cost for all users or if software not free then the minimum 10 licenses must be provided for users.

 The system's software must include a one-click configuration tool that sets up the software for standard and user-defined operation modes, such as contact/ non-contact mode imaging and EFM, KPFM, PFM, force measurements, etc.

 Software must include a feature that automatically optimizes parameter and acquisition of AFM topography without the needs of setup parameters like set-point, gains, and etc.

 The feature must not use any predictive algorithm and the software must allow adjust/control of AFM feedback parameter in real time.

 The data acquisition software should include modes, such as Auto Modes for new users and Manual Modes for expert user.

 The data acquisition software should be user friendly, which enable new operator able to acquire topography images

 AFM control software environment must include 3D rendering technology for advanced image display. This feature must allow the user to generate, display and visualize 3D images, as well as off-line processing.

The data acquisition software should allow users to plot any two signal channels on the same real-time dual-axis graph for comprehensive analysis.

The data acquisition software must have built-in macros, which can be easily loaded and applied for repeating operations, such as moving the XY or the Z stage to a specific
