Technical Specification for Genetic analyzer

- 1. Equipment must be a compact single integrated unit. Should perform advanced fully automated multi-capillary, fluorescence-based DNA Sequencing analysis.
- 2. Equipment should be a licensed version and the vendor should quote user license to perform the sequencing reaction.
- Equipment should be able to do high performance sequencing reaction with wide range of chemicals and chemistry.
- 4. Equipment should come with 8 or more capillaries in parallel that employ bare silica capillaries with a usage life that exceeds 160 runs. The system should have an option to upgrade to more capillaries to meet future throughput necessities.
- Equipment should have the capacity to perform Serial analysis of gene expression sequencing, expressed sequence tag sequencing, gene regulation studies, microbial diversity analysis, epigenetic change analysis, genome analysis as well as re-sequencing.
- 6. Equipment should have noise free CCD detection technology and a spectrograph for color separation.
- Equipment should have the ability to detect and analyze 6 or more fluorescent dyes simultaneously for DNA fragment analysis.
- 8. Equipment should come with single line 505 nm Solid-State long-life laser, utilizing a standard excitation source with power supply and without heat removal ducting.
- 9. Equipment should have signal uniformity and sensitivity with dual side illumination detection. It should be active at various temperatures in the range between 18 to 70°C.
- 10. Equipment should have option for different capillary sizes for smaller fragment and large fragment sequencing analysis.
- Equipment should come with automatic Radio-Frequency Identification Technology to track key consumables data. In addition, the equipment should have the option to override the expiry date-based system.
- 12. An anti-vibration table of any makes to be supplied for placing the equipment with appropriate dimensions.
- 13. The supplier should offer a personal computer along with the instrument with following specifications to acquire raw data. - 14. The supplier should supply a powerful workstation that supports various sequence analysis with the following configurations: Intel Xeon processor with minimum 2 Core, 2.10 Ghz; 32 GB DDR4 RAM or above, 1 TB SSD or above, 23" or above widescreen LCD monitor and 4 or more USB 3.1 ports, 1 Serial, Parallel, Ethernet ports; Intel Dual Band Wireless and activated Windows 10 Pro 64.
- 15. The vendor should supply all the necessary software for de novo, contig assembly, Re-sequencing, Long Read Sequencing, comparative sequencing, Fragment analysis applications like SSR, ISSR, AFLP Plant & Microbial Finger printing, HMA (Heteroduplex Mobility Assay), Microsatellite, Long Sizing, SSCP, SNP Validation and screening, Linkage analysis, LOH (Loss of Heterozygosity).
- 16. The software should allow real-time data quality evaluation providing immediate access to base calling or size calling data to make decision about the quality of data as it is generated.

- 17. The vendor should supply all the necessary consumables and reagents to perform minimum 2000 sequencing reactions along with the instrument, with an adequate shelf life.
- 18. The supplier should perform installation, application, and operator training on site.
- 19. Should support by trained operator for minimum of three visits per year for two years for technical training.
- Additionally, support with trained engineer for minimum of three visits per year for two years for maintenance.
- 21. All the equipment must support 220 Volt, 50 Hz electrical systems.
- Equipment should come with three years comprehensive warranty on all components including laser and the required service kits for the warranty period.

- 24. ANNEXURE- 2: SPECIAL CONDITIONS OF CONTRACT ELIGIBLE BIDDERS. 1.1.1 This Invitation for Bids is open to all suppliers. Bidders should not be associated, or have been associated in the past, directly or indirectly, with a firm 1.1.2 or any of its affiliates which have been engaged by the Purchaser to provide consulting services for the preparation of the design, specifications, and other documents to be used for the procurement of the goods to be purchased under this Invitation of Bids. 1.2. COST OF BIDDING The Bidder shall bear all costs associated with the preparation and submission of its bid, and "the 1.2.1 Purchaser", will in no case be responsible or liable for these costs, regardless of the conduct or outcome of the bidding process. 1.3. FRAUD AND CORRUPTION: 1.3.1 The purchaser requires that the bidders/suppliers and contractors observe the highest standard of ethics during the procurement and execution of such contracts. The purchaser will reject a proposal for award if it determines that the Bidder recommended for award 1.3.2 has, directly or through an agent, engaged in corrupt, fraudulent, collusive or coercive practices in competing for the Contract in question; The Bidding Documents 1.4. COST OF BIDDING DOCUMENTS Interested eligible bidders may download the document from our Website. However the bid document 1.4.1 cost to be paid during the submission of the bid. 1.5. CONTENT OF BIDDING DOCUMENTS The goods required, bidding procedures and contract terms are prescribed in the bidding documents 1.5.1 which should be read in conjunction. 1.5.2 The Bidder is expected to examine all instructions, forms, terms, and specifications in the bidding documents. Failure to furnish all information required by the bidding documents or submission of a bid not substantially responsive to the bidding documents in every respect will be at the Bidder's risk and may result in rejection of its bid. CLARIFICATION OF BIDDING DOCUMENTS 1.6. 1.6.1 A prospective Bidder requiring any clarification of the Bidding Documents shall contact the Purchaser in writing via fax/email. The Purchaser will respond in writing to any request for clarification, provided that such request is received not later than ten (10) days prior to the deadline for submission of bids. The Purchaser shall forward copies of its response to all those who have acquired the Bidding Documents directly from it, including a description of the inquiry but without identifying its source. Should the Purchaser deem it necessary to amend the Bidding Documents as a result of a clarification, it shall do so following the procedure under clause relating to amendment of Bidding documents and Clause relating to Deadline for Submission of Bids. The clarifications and amendments issued would also be hosted on the website of the purchaser for the benefit of the other prospective bidders. 1.7. AMENDMENT OF BIDDING DOCUMENTS At any time prior to the deadline for submission of bids, the Purchaser may, for any reason, whether at 1.7.1 its own initiative or in response to a clarification requested by a prospective bidder, modify the bidding documents by amendment. 1.7.2 All prospective bidders who have received the bidding documents will be notified of the amendment in writing or by e-mail and will be binding on them. The same would also be hosted on the website of the purchaser and all prospective bidders are expected to surf the website before submitting their bids to take cognizance of the amendments. 1.7.3 In order to allow prospective bidders reasonable time to take the amendment into account, while in preparing their bids, the Purchaser, at its discretion, may extend the deadline for the submission of bids and host the changes on the website of the purchaser. In case of any amendment to the bid, it will be done at least 7 days before due date and will be 1.7.4 published in website. Bidders are required to keep this in view before submission. Normally extension of due date will not be entertained. However in special cases if due date is extended, it will be notified under the same tender notice before 3 days of due date. PREPARATION OF BIDS LANGUAGE OF BID 1.8. The bid prepared by the Bidder, as well as all correspondence and documents relating to the bid 1.8.1 exchanged by the Bidder and the Purchaser, shall be written in English language only especially when the details are technical. However of GOI makes it mandatory under Rajbhasha Abhniyam in that case views of Rajbasha unit of IISER-TVM may be sought. 1.8.2 The Supplier shall bear all costs of translation, if any, to the English language and all risks of the accuracy of such translation, for documents provided by the Supplier.

1.10. BID FORM AND PRICE SCHEDULE

1.10.1 The bidder shall complete the Bid with the appropriate price schedule.

1.11. BID PRICES

- 1.11.1 The Bidder shall indicate on the appropriate price schedule, the unit prices and total bid prices of the goods it proposes to supply under the contract.
- 1.11.2 Prices indicated on the price-schedule form shall be entered separately in the following manner:

(A) FOR GOODS MANUFACTURED WITHIN INDIA

IISERTVM has a mechanism for consolidation and customs clearance. The consolidators will be nominated for this purpose at the time of awarding the contract if desires so.

(i) The price of the goods, quoted on FCA (named place of delivery abroad) or FOB (named port of shipment), as specified in the price schedule.

(ii) The charges for insurance and transportation of the goods to the port/place of destination.

(iii) The agency commission charges should be shown, if any.

(iv) The installation, commissioning and training charges including any incidental services, if any

- 1.11.3 The terms FOB, FCA, CIF, CIP etc shall be governed by the rules prescribed in the current edition of the Incoterms published by the International Chambers of Commerce, Paris.
- 1.11.4 Where there is no mention of packing, forwarding, freight, insurance changes, taxes etc. such offer shall be rejected as incomplete.
- 1.11.5 The price quoted shall remain fixed during the contract period and shall not vary on any account
- 1.11.6 All lots and items must be listed and priced separately in the Price Schedules. If a Price Schedule shows items listed but not priced their prices shall be assumed to be included in the prices of other items. Lots or items not listed in the Price Schedule shall be assumed to be not included in the bid.
- 1.11.7 The purchases made by the purchaser for scientific purpose are exempt from GST under 45/17, 47/17 notification and Custom Duty under notification 51/96.

1.12. BID CURRENCIES

- 1.13.1 The bidder shall furnish, as part of its bid, documents establishing the bidders' eligibility to bid and its qualification to perform the contract if its bid is accepted.

(a) The bidder meets the qualification criteria listed in bidding documents, if any.

- (b) Bidder that doesn't manufacture the goods it offers to supply shall submit to Manufacturers' Authorization Form (MAF) to demonstrate that it has been duly authorized by the manufacturer of the goods to quote and/or supply the goods.

In the case of foreign bidders, the BS shall be submitted either by the principal or by the Indian agent and in the case of indigenous bidders; the BS shall be submitted by the manufacturer or their specifically authorized dealer/bidder. CONFIDENTIALITY 1.17.1 Information relating to the examination, evaluation, comparison, and post qualification of bids, and recommendation of contract award, shall not be disclosed to bidders or any other persons not officially concerned with such process until publication of the Contract Award. 1.17.2 Any effort by a Bidder to influence the Purchaser in the examination, evaluation, comparison, and post qualification of the bids or contract award decisions may result in the rejection of its Bid. 1.18. CLARIFICATION OF BIDS 1.18.1 To assist in the examination, evaluation, comparison and post qualification of the bids, the Purchaser may, at its discretion, ask the Bidder for a clarification of its bid. 1.23. WARRANTY

1.23.1 The Supplier warrants that all the Goods are new, unused, and of the most recent or current models, and that they incorporate all recent improvements in design and materials, unless provided otherwise in the Contract.

1.23.2 The Supplier further warrants that the Goods shall be free from defects arising from any act or omission of the Supplier or arising from design, materials, and workmanship, under normal use in the conditions prevailing in India.

1.23.3 Unless otherwise specified, the warranty shall remain valid for twelve (12) months after the Goods, or any portion thereof as the case may be, have been delivered to and accepted at the final destination indicated, or for eighteen (18) months after the date of shipment from the port or place of loading in the country of origin, whichever period concludes earlier.

1.23.4 The Purchaser shall give notice to the Supplier stating the nature of any such defects together with all available evidence thereof, promptly following the discovery thereof.

The Purchaser shall afford all reasonable opportunity for the Supplier to inspect such defects.

1.29.5 Upon receipt of such notice, the Supplier shall, within a reasonable period, expeditiously repair or replace the defective Goods or parts thereof, at no cost to the Purchaser.

1.23.6 If having been notified, the Supplier fails to remedy the defect within the reasonable period; the Purchaser may proceed to take within a reasonable period such remedial action as may be necessary, at the Supplier's risk and expense and without prejudice to any other rights, which the Purchaser may have against the Supplier under the Contract.

Subject to GC Clause on Force Majeure, if the Supplier fails to deliver any or all of the Goods or to perform the Services within the period(s) specified in the Contract, the Purchaser shall, without prejudice to its other remedies under the Contract, deduct from the Contract Price, as penalty, a sum equivalent to the percentage specified in contract of the delivered price of the delayed Goods or walker formed Services or contract value for each week or part thereof of delay until actual delivery or

1.25 INSURANCE

- Should the purchaser elect to buy on CIF/CIP basis, the Goods supplied under the Contract shall be 1.25.1 fully insured in Indian Rupees against any loss or damage incidental to manufacture or acquisition, transportation, storage and delivery in the manner specified in contract.
- Where delivery of the goods is required by the purchaser on CIF or CIP basis the supplier shall arrange 1.25.2 and pay for Cargo Insurance, naming the purchaser as beneficiary and initiate & pursue claims till settlement, on the event of any loss or damage.
- 1.25.3 Where delivery is on FOB or FCA basis, insurance would be the responsibility of the purchaser.

Where the Supplier is required under the Contract to deliver the Goods FCA, transport of the Goods and delivery into the custody of the carrier at the place named by the Purchaser or other agreed point shall be arranged and paid for by the Supplier, and the cost thereof shall be included in the Contract price.
- Where the Supplier is required under the Contract to deliver the Goods CIF or CIP, transport of the 1.26.2 Goods to the port of destination or such other named place of destination in the Purchaser's country, as shall be specified in the Contract, shall be arranged and paid for by the Supplier, and the cost thereof shall be included in the Contract Price.
- In the case of supplies from within India, where the Supplier is required under the Contract to 1.26.3 transport the Goods to a specified destination in India, defined as the Final Destination, transport to such destination, including insurance and storage, as specified in the Contract, shall be arranged by the Supplier, and the related costs shall be included in the Contract Price.

1.38 STANDARDS

> The Goods supplied and services rendered under this Contract shall conform to the standards mentioned in the Technical Specifications and Schedule of Requirements, and, when no applicable standard is mentioned, to the authoritative standard appropriate to the Goods' country of origin and such standards shall be the latest issued by the concerned institution.

1.39 PERFORMANCE SECURITY

- Within 21 days of receipt of the notification of award/PO, the Supplier shall furnish performance 1.39.1 security of 7% of Contract/ Purchase Order value in the amount specified in the Contract, valid till 60 days beyond the completion of contractual obligations.
- The proceeds of the performance security shall be payable to the Purchaser as compensation for any 1.39.2 loss resulting from the Supplier's failure to complete its obligations under the Contract.
- The Performance Security shall be denominated in Indian Rupees for the offers received for supplies 1.39.3 within India and denominated in the currency of the contract in the case of offers received for supply from foreign countries.
- In the case of imports, the PS may be submitted either by the principal or by the Indian agent and, in 1.39.4 the case of purchases from indigenous sources, the PS may be submitted by either the manufacturer or their authorized dealer/bidder.
- The Performance security shall be in one of the following forms: 1.39.5

A Bank guarantee or stand-by Letter of Credit issued by a Nationalized/Scheduled bank cated in India or a bank located abroad in the form provided in the bidding documents. Or, A Banker's cheque or Account Payee demand draft in favour of the purchaser. Or, Deposit Receipt pledged in favor of the Purchaser.

PAYMENT TERMS

For Indigenous supplies payment will be made within 30 days from the date of supply, installation and commissioning. For Imported goods, the preferred payment mode of the Institute is Sight Draft /Net 30 days. If the vendors insist Letter of Credit, the LC will be established for 100% of Purchase Order value out of which 90% will be paid against shipping evidence and 10% after installation and commissioning and on submission of Performance Bank Guarantee for 10% of Purchase Order value which should be valid during warranty period.

However, the advance payment to the vendors is not encouraged.
