#### 1) Information & Instructions for Online Bid Submission:

This tender document has been published on the Central Public Procurement Portal (<u>URL:https://eprocure.gov.in/eprocure/app</u>) & Institute website <u>www.iisertvm.ac.in</u>. The bidders are required to submit soft copies of their bids electronically on the CPP Portal, using valid Digital Signature Certificates. The instructions given below are meant to assist the bidders in registering on the CPP Portal, prepare their bids in accordance with the requirements and submitting their bids online on the CPP Portal. More information useful for submitting online bids on the CPP Portal may be obtained at:

- 1.1 The intending bidder must read the terms and condition of NIT carefully. Bidder should submit hisbid only if he considers himself eligible and he is in possession of all the required documents.
- 1.2 Bid documents should be submitted online complete in all respect along with requisite amount of tender fee (cost of bid documents). Cost of tender documents shall be remitted to IISER TVM by online payment through **State Bank Collect**. Complete set of tender documents comprising Volume I, II has been made available at e-tender portal (URL:https://eprocure.gov.in/eprocure/app)
- 1.3 The bidder would be required to register at e-tender portal (<u>URL:http://eprocure.gov.in/eprocure/app</u> For submission of the bids, the bidder is required to have digital Signature Certificate (DSC) from one of the authorized Certifying Authorities.
- 1.4 Information and instruction for bidders posted on website shall form part of the bid document.
- 1.5 The bid document consisting of Vol.I Tender conditions, Vol-II- Financial Bid (BOQ) and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from website (<u>URL:https://eprocure.gov.in/eprocure/app</u>)free of cost.
- 1.6 But the bid can only be submitted after uploading the mandatory scanned documents such as receipt of online payment towards tender fee, in favour of IISER THIRUVANANTHAPURAM, scan copies of other required documents as specified in the NIT. The tender fee should be deposited online with IISER THIRUVANANTHAPURAM within the period of bid submission as specified in the bid document.

- 1.7 Those contractors not registered on the website mentioned above, are required to get registered beforehand. If needed they can get imparted to training on online tendering process as per details available on the website. The intending bidder must have valid class-III digital signature to submit the bid.
- 1.8 On opening date, the contractor can login and see the bid opening process. After opening of bids he will receive the competitor bid sheets.
- 1.9 Contractor can upload documents in the form of JPG format and PDF format. Certificate of Financial Turn over: At the time of submission of bid contractor may upload Affidavit/ Certificate from CA mentioning Financial Turnover for the last 3 years or for the period as specified in the bid document and further details if required may be asked from the contractor after opening of technical bids. There is no need to upload entire voluminous balance sheet.
- 1.10Contractor has to quote item rate the total estimated cost put to tender and in case bidder quote % rate in the BOQ, then tender shall be rejected.
- 1.11The tender document can be downloaded from <u>http://eprocure.gov.in/eprocure/app</u> and be submitted only through the same website.

#### 2. Registration of Bidder on e-Procurement Portal

- 2.1 Bidders are required to enroll on the e-Procurement module of the Central Public Procurement Portal (<u>URL:http://eprocure.gov.in/eprocure/app</u>) by clicking on the link "Click here to Enroll". Enrolment on the CPP Portal is free of charge.
- 2.2 As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.
- 2.3 Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the CPP Portal.
- 2.4 Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (Class II or Class III Certificates with signing key usage) issued by any Certifying Authority recognized by CCA India (e.g. Sify/TCS/nCode/eMudhra etc.), with their profile.
- 2.5 Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSCs to others which may lead to misuse.
- 2.6 Bidder then logs into the site through the secured log-in by entering their user ID/password and the password of the DSC / eToken.
- 2.7 The CPP Portalal also has user manual with detailed guide lines on enrollment and participation in the online bidding process. Any queries related to process of online bids or queries related to CPP Portal may be directed to the 24x7 CPP Portal Helpdesk.

#### 3. SEARCHING FOR TENDER DOCUMENTS

- 3.1 There are various search options built in the CPP Portal, to facilitate bidders to search active tenders by several parameters. These parameters could include Tender ID, organization name, location, date, value, etc. There is also an option of advanced search for tenders, wherein the bidders may combine a number of search parameters such as organization name, form of contract, location, date, other keywords etc. to search for a tender published on the CPP Portal.
- 3.2 Once the bidders have selected the tenders they are interested in, they may download the required documents / tender schedules. These tenders can be moved to the respective 'My Tenders' folder. This would enable the CPP Portal to intimate the bidders through SMS/e-mail in case there is any corrigendum issued to the tender document.
- 3.3 The bidder should make a note of the unique Tender ID assigned to each tender, in case they want to obtain any clarification / help from the Helpdesk.

#### 4. PREPARATION OF BIDS

- 4.1 Bidder should take into account any corrigendum published on the tender document before submitting their bids.
- 4.2 Please go through the tender advertisement and the tender document carefully to understand the documents required to be submitted as part of the bid. Please note the number of covers in which the bid documents have to be submitted, the number of documents including the names and content of each of the document that need to be submitted. Any deviations from these may lead to rejection of the bid.
- 4.3 Bidder, in advance, should get ready the bid documents to be submitted as indicated in the tender document / schedule and generally, they can be in PDF / XLS formats. Bid documents may be scanned with 100 dpi with black and white option.
- 4.4 To avoid the time and effort required in uploading the same set of standard documents which are required to be submitted as a part of every bid, a provision of uploading such standard documents (e.g. PAN card copy, annual reports, auditor certificates etc.) has been provided to the bidders. Bidders can use "My Space" area available to them to upload such documents. These documents may be directly submitted from the "My Space" area while submitting a bid, and need not be uploaded again and again. This will lead to a reduction in the time required for bid submission process.

#### 5. SUBMISSION OF BIDS

- 5.1 Bidder should log into the site well in advance for bid submission so that he/she upload the bid in time i.e. on or before the bid submission time. Bidder will be responsible for any delay due to other issues.
- 5.2 The bidder has to digitally sign and upload the required bid documents one by one as indicated in the tender document.
- 5.3 A standard BOQ format has been provided with the tender document to be filled by all the bidders. Bidders are requested to note that they should necessarily submit their financial bids

in the format provided and no other format is acceptable. Bidders are required to download the

BOQ file, open it and complete the white colored (unprotected) cells with their respective financial quotes and other details (such as name of the bidder). No other cells should be changed. Once the details have been completed, the bidder should save it and submititonline, without changing the filename. If the BOQ file is found to be modified by the bidder, the bid will be rejected.

- 5.4 The server time (which is displayed on the bidders' dashboard) will be considered as the standard time for referencing the deadlines for submission of the bids by the bidders, opening of bids etc. The bidders should follow this time during bid submission.
- 5.5 The uploaded tender documents become readable only after the tender opening by the authorized bid openers.
- 5.6 Upon the successful and timely submission of bids, the portal will give a successful bid submission message & a bid summary will be displayed with the bid no. and the date & time of submission of the bid with all other relevant details.

- 7. #### 8. Bid Security/EMD and Tender fee.

- 9.1 Bid Security/EMD amounting to Rs. 20,990/- and tender fee of Rs. 560/-(Including 12% GST charges) shall be deposited in IISER THIRUVANANTHAPURAM Bank account through State Bank Collect as detailed below failing which the bid will be declared non responsive. - 9.4 A part of earnest money is acceptable in the form of bank guarantee also. In such case, 50% of earnest money or Rs.20 lakh, whichever is less, will have to be deposited in shape prescribed above and balance in shape of irrevocable Bank Guarantee from a Scheduled Bank and shall be valid 120 days from the last date of receipt of bid as per standard proforma attached.
- 9.5 Scanned copy of the net banking transaction receipt towards payment of tender fee shall be uploaded on the e-tendering website within the period of bid submission failing which the bid will be declared non responsive.
- 9.6 Bid Security/EMD of unsuccessful Bidders will be returned to them within 90 days from the date of acceptance of bid of the successful Bidder.
- 9.7 The Bid Security/EMD may be forfeited, if
  - a) The bidder withdraws / modifies his Bid or any item thereof after opening of bid.
  - b) The successful Bidder fails within the specified time limit to commence the work.

Only relevant answers shall be answered and IISER THIRUVANANTHAPURAM shall not be responsible for delay in getting the answers.
- 12. If any amendment in the tender document uploaded on the website is necessitated due to any query raised by any bidder including the text of the questions raised (without identifying the source of enquiry) and the responses given will be uploaded as corrigendum on websites (URL:https://eprocure.gov.in/eprocure/app) and www.iisertvm.ac.in Bidders are requested to take note of the corrigendum and quote their rates accordingly. In case revised BOQ is uploaded on website by IISER, tenderer /bidder has to quote in revised BOQ only. The uploading quotation in pre-revised BOQ shall be considered as a willful negligence by the bidder and his quotation shall be considered as non-responsive.

#### 13. Cost of Bidding

The Bidder shall bear all costs associated with the preparation and submission of his Bid, and the IISER THIRUVANANTHAPURAM will in no case be responsible and liable for these costs.

#### 14. Site visit & availability of site.

- a) The Bidder should inform the IISER in advance about the proposed site visit.
- b) The Bidder, at his own responsibility and risk is encouraged to visit, inspect and Survey the Site and its surroundings and satisfy himself before submitting his Bid as to the form and nature of the Site, the means of access to the Site, the Accommodation he may require etc.
- c) In general, Bidders shall themselves obtain all necessary information as to risks, contingencies and other circumstances which may influence or affect their bid. A Bidder shall be deemed to have full knowledge of the Site, whether he inspects it or not and no extra claims due to any misunderstanding or otherwise shall be allowed.
- d) The costs of visiting the Site shall be at the Bidders' own expense. Any report shared at the site, by the IISER is subject to verification by the contractor. Any deviations of information in the report and the actual site will not be the responsibility of the IISER.
- e) The site for the work is available for visit from the date of issue of the tender.
- f) The architectural and structural drawings shall be made available in phased manner as per requirement of the same as per approved program of completion submitted by the contractor after award of the work.

#### 15. Content of Bidding Documents

- a) Submission of a bid by a Bidder implies that he has read this notice and all other contract documents and has made himself aware of the scope and specifications of the work to be executed and local conditions and other factors having a bearing on the execution of the works.
- b) The Bidder shall submit the Bid, which satisfies each and every condition laid down in the Bid documents, failing which, the bid is liable to be rejected.
- c) Notice inviting e-Tender shall form part of the Contract document.
- d) The rate quoted in the price bid shall be inclusive of all taxes, freight charges etc. no extra shall be claimed.

#### 16. Amendment of Bid Documents

Before the deadline for submission of bids, the IISER THIRUVANANTHAPURAM may modify the bidding documents by issuing corrigendum. Any corrigendum so issued shall be part of the bid documents as well as Contract document and shall be on uploaded website <u>URL:https://eprocure.gov.in/eprocure/app</u> and <u>www.iisertvm.ac.in</u> Bidders should take note of the uploaded corrigendum and submit the tenders accordingly.

#### 17. Bid Validity

- a. The bid submitted shall become invalid if:
  - (i) The bidders is found ineligible.
    - (ii) The bidder does not deposit online tender fee and EMD with IISER THIRUVANANTHAPURAM before the date and time fixed for opening of the bids.
    - (iii) The bidders does not upload all the documents (including GST registration) as stipulated in the bid document.
    - (iv) If any discrepancy is noticed between the documents as uploaded at the time of submission of bid and hard copies as submitted physically by the lowest tenderer in the office of tender opening authority.
- b. The bids submitted shall remain valid for acceptance for a period of 90 days from the date of opening of the technical bids. If any bidder withdraws his tender before the said period or issue of letter of acceptance, whichever is earlier, or makes any modifications in the terms and conditions of the tender which are not acceptable to the IISER, THIRUVANANTHAPURAM, then the IISER, THIRUVANANTHAPURAM shall, without prejudice to any other right or remedy, be at liberty to forfeit 50% of the said earnest money as aforesaid. - c) Any effort by the Bidder to influence the IISER's bid evaluation, bid comparison or contract award decisions, may result in the rejection of his bid.

ANDWHEREAS the Principal/Owner values full compliance with all relevant laws of the land, rules, regulations, economic use of resources and of fairness/transparency in its relation with its Bidder(s) and Contractor(s).

ANDWHEREAS to meet the purpose aforesaid both the parties have agreed to enter into this Integrity Agreement (hereinafter referred to as "Integrity Pact" or "Pact"), the terms and conditions of which shall also be read as integral part and parcel of the Tender/Bid documents and Contract between the parties.

NOW, THEREFORE, in consideration of mutual covenants contained in this Pact, the parties hereby agree as follows and this Pact witnesses as under:

#### Article 1: Commitment of the Principal/Owner

The panels shall conform to IS: 8623/1993. All panels shall be powder coated inside out, in shade approved by the Engineer-in-charge.
- 17. All model of modular accessories required for the work shall be got approved from the Engineer-in-charge among the approved makes. The base plate shall be preferably in sheet steel or otherwise in unbreakable polycarbonate. The cover plates shall be screw less type in shade approved by the Engineer-in-charge. The uPVC / GI box shall be of the same make as the modular accessories.

- 18. The MCB shall be of the same make as that of MCB DB's. Contractor shall obtain approval of the Engineer-in-charge before procurement of MCB DB's. All DB's shall be double door type confirming to minimum IP-43 degree of protection.
- 19. Miniature Circuit Breaker shall comply with IS -8828-1996 / IEC 898 with latest amendments up to date. Miniature Circuit Breakers shall be quick make and break type for 230 / 415 V A.C. ,50Hz application with magnetic thermal release for over current and short circuit protection. The breaking capacity shall not be less than 10KA at 415V A.C. The MCB shall be DIN mounted. The MCB shall be current limiting type (class 3).
- 20. MCB shall have the minimum power loss (watts) per pole defined as per the IS / IEC and the manufacturer shall publish the values.
- 21. The MCB housing shall be heat resistant and having high impact strength. The terminal shall be protected against finger contact to IP20 degree of protection.
- 22. All the MCCB's shall have microprocessor based trip unit for reliable protection and accurate measurement. The rated Service breaking capacity (kArms) shall be 100% of Ultimate breaking capacity (kArms). All MCCB's shall be current limiting type with features as per relevant IS codes and CPWD specification. All MCCB's shall be rated for minimum operating voltage of 690 V and minimum insulation voltage of 750 V. There has to be total discrimination between the incoming and outgoing MCCB's and MCB's, as required, at the MDB's and DB's level.
- 23. MCCB's shall be used with rotary handle and terminal spreaders and all terminals shall be shrouded to avoid direct contact.
- 24. Breaker shall have LCD display to show the metering and protection parameters.
- 25. All measuring CT's, unless otherwise specified shall be cast resin CT's with class 0.5 accuracy. All digital measuring meter shall be with class 0.5 accuracy unless specified otherwise.
- 26. Mechanical Castle key interlock shall be provided among the incomer MCCB's, wherever, as applicable, two different incomer sources are provided in the panel as per the directions of the Engineer in charge. The same is deemed included in the scope of work.

- 27. All measuring and indicating instruments shall be protected through MCB's of 2 Amps rating.
- 28. Ratings, sizes and quantities shall be checked and considered for satisfactory operation of electrical system complete in all respect. Ratings, sizes and quantities mentioned in Bill of Quantities and drawings are indicative and minimum.
- 29. General arrangement drawing of the switchboard shall be got approved the Engineer-in-Charge before commencement of manufacturing.
- 30. HT Panels, Transformers, Bus ducts, Rising Mains with accessories, MV panels and APFC panels will be inspected in the respective manufacturer works before dispatch and routine test as applicable as per BIS standards will be provided for each equipment. During the testing the Engineer-in-charge will ensure compliance with the agreement conditions and approved drawings.
- 31. It is important that every equipment is tested fully before dispatch.
- 32. All materials for the work shall be supplied from approved list of manufacturer and any item, not covered in approved list, shall be supplied after getting approval from Engineer- in-charge or his authorized representative.
- 33. Any materials brought for work which is not matching with specification will be rejected and the rejected materials shall be removed from site on the same day.
- 34. Test certificates both type test and routine tests wherever required shall be furnished along with supply for all Electrical/Mechanical items.
- 35. Balance works including final alignment, installation, testing and commissioning works are the responsibility of contractor.
- 36. The contractor can visit the site and asses the nature and quantities of work involved for successful completion of work in time, on all working days between 10.00 Hrs. to 16.00 Hrs. before submitting the tender. After submission of tender no claims in this regards will be considered.
- 37. For all installation works nuts, bolt, washer, screws, PVC/steel fastener, wire lug, and other accessories required for completion of work shall be in contractor's scope without any additional charges.

- 38. For all items Contractor has to complete all associated minor civil work/cleaning for making good as per direction of engineer in charge without any additional charges.
- 39. In all installation/test works, if any component/equipment has to be replaced, that shall be arranged by the contractor at his own risk and cost. A proper rate analysis with proof of invoice/Chelan shall be submitted for additional claim.
- 40. Any damage to the component/equipment/material due to mistake from the part of contractor has to be rectified/ replaced by the contractor as per the direction of Engineer in charge without any additional charge.
- 41. Contractor shall have to check the site order Book for any instructions of Engineer-in-charge or his authorized representative and sign the site order book. He shall be bound to ensure compliance with the instructions recorded there in.
- 42. Contractor has to do the work in co-ordination with other contractors, agencies, and systems as required and as directed by the engineer in charge.
- 43. All necessary equipment for testing and commissioning shall be arranged by the contractors without any additional charges.
- 44. Conduit layout shall be prepared by contractor and got approved from the Engineer-in-Charge before slab casting. At all expansion joints in the building suitable arrangement shall be ensured during conduiting.
- 45. Conduits, Switchboards, Sockets to be provided on walls shall be recessed type unless specifically approved by Engineer-In-Charge. For wall chasing work proper electric wall chaser must be used.
- 46. Conduits on ceiling in existing system may be provided on surface and in new construction shall be recessed type.
- 47. The contractor has to do necessary arrangement for uncoiling of the LT cables from the cable drum kept in the cable yard and transport the cables upto the respective site.
- 48. Recovery rate for items specified in schedule-B will be double the rate beyond permissible wastage.(for items which covers installation part in SOQ)
- 49. The agency shall have the following testing/measuring equipments in addition to standard tools.

- a. Digital Multi-meter for Direct and alternating voltages from  $100\mu V$  ... 1000V, Direct and alternating currents from  $10\mu A$  ... 10.00A, Resistance from  $1\Omega$ ...  $60.00M\Omega$ , Capacitance from 1pF ... 40.00 mF with zero correction, Frequencies from 10.00Hz ... 10MHz, Diode measurement and continuity testing, Duty cycle (%) measurement, Temperature measurement with K type Thermocouple, Peak value measurement.
- b. Insulation Tester for measuring range from 10KOhm to 1TOhm, Test voltages: 100V, 250V, 500V, 1000V, 1500V, 2000V, 2500V, 5000V.
- c. Earth tester with kit, 0-100 ohms with multiple ranges and selector switches.
- d. Tong tester (clamp meter) of range 0 to 1000 A with multiple ranges and selector switches.
- e. Phase sequence tester
- f. Frequency meter 45 to 55 Hz.
- g. Portable PF meter of range Lead 0.5 to 1.0 to 0.5 lag
- h. Lux meter to measure up to 2000 lux with selector switches.
- i. Digital Micrometer and Digital Vernier Caliper
- 50. The contractor shall quote his rates / supply on the basis of the price of best quality product of the brand/make as per the List of approved makes. In any case particular brand of item is not acceptable to the client the contractor shall supply items of other approved brands at no extra cost.
